



Information clause regarding personal data¹

- The Controller of your personal data is: Institute for Ecology of Industrial Areas (IETU) in Katowice, 40-844, 6 Kossutha Street.
- You can contact our Data Protection Officer - iodo@ietu.pl
- The basis for processing of these data is: point (a) Article 6 (1) GDPR - the consent, and point (f) Article 6 (1) GDPR -the legitimate interests of the Controller in terms of meeting the requirements of the financing party, i.e. documenting the number of participants by conference attendance lists;
- Your personal data will be processed for the purposes related to participation in the Conference, including the implementation of security requirements applicable at the Muzeum Śląskie, IETU promotion (LUMAT project) and correct documentation and reporting of the LUMAT project.
- Permission to use the image will allow you to occupy any place in the conference room. People who do not agree will have to take their place in a specially marked sector.
- Your personal data may be shared with other entities, including:
 - IETU service providers - Muzeum Śląskie, provider of electronic mail servers: home.pl;
 - institutions authorized to supervise IETU activity;
 - entities authorized to obtain personal data on the basis of separate legal provisions;
 - **in the case of the image**, it will be distributed and published in the press, brochures, leaflets, newsletters, etc. and in materials used to popularize IETU in the following areas: in electronic media, in particular through the uploading and storage in the computer's memory, on websites, it will also be transmitted via the Internet, etc.;
 - **In the case of a diet**, it will be transferred to the catering company in an anonymous manner (identification of the person will not be possible).
- Personal data will be processed for the following periods and then will be anonymized.
 - for a period of 6 months - in the case of personal data processed for the purpose of conducting the Conference;
 - for a period of 5 years - in the case of personal data processed in order to inform about current and future events related to the dissemination of research results by IETU, after giving consent;
 - for a period of 3 years or 10 years + 1 year - in relation to personal data processed in order to establish, investigate and defend claims;
 - until the consent is withdrawn or the purpose of processing is achieved, but for no longer than 5 years - in relation to personal data processed on the basis of consent, unless the consent is withdrawn earlier than before the end of the indicated period;
 - until the opposition is effectively addressed or the purpose of the processing is achieved, but for no more than 10 years - in relation to personal data processed on the basis of the legitimate interest of the controller.
- You have the right to request access to your personal data, rectification, deletion or limitation of processing or opposition to data processing from the Administrator.
- You have the right to transfer your personal data, i.e. to receive information from the Controller about the processing of your personal data which you provided to IETU, in a structured, commonly used, machine-readable and interoperable format in the scope in which data is processed on the basis of consent.
- Your rights: the right to access your personal data, correct and rectify them, remove or limit the processing of personal data, the right to transfer personal data, the right to object to the processing of personal data, and the right to lodge a complaint to the supervising authority (the President of the Personal Data Protection Office), providing it does not prejudice the rights of third parties..
- Your personal data will not be subject to automated decision making or profiling.
- Your personal data will not be transferred to non-EU countries and international organizations.
